Waste Disposal Plan (Post-Closure)

BE IT RESOLVED, that as a transitionary period from the landfill closure September 30, 2021 to December 31, 2021 the RM shall provide waste disposal service at the site, as follows:

- One (1) 30-yard waste bin (provided by Greenland Waste) for general household waste;
- One (1) 30-yard recycle bin (provided by Greenland Waste) for recyclable waste;
- One (1) metal bin for scrap metal, if a metal recycler is able to provide a bin at no cost;
- All waste shall be contained in bins, as such wood/brush and tires are prohibited;
- Hours of operation shall be Saturday's 10:00am – 4:45pm;
- Bin Attendant Service Contract shall be offered to Vernon Holland;
- Tokens shall be accepted or \$5.00 cash deposited with the attendant;
- Patrons must be an RM of Invergordon ratepayer;
- All bins shall be removed and the site permanently closed as of January 1, 2022;
- Greenland Waste's discounted rate of \$30.00*/month on 3-yard waste bins shall come into effect October 1, 2021 for all RM of Invergordon ratepayers who require a bin for their property. Bins shall be paid for by the ratepayer.

*This rate reduces to \$20.00/month once their commercial non-hazardous landfill site is operational.

BE IT FURTHER RESOLVED, that a Public Notice be issued with the above information.
