*First Reading – Zoning Bylaw & Official Community Plan Bylaw*

**291/23 Bacon**

WHEREAS, Official Community Plan Bylaw 23-07 shall provide a comprehensive policy framework to guide the physical, economic, social and cultural development of the RM of Invergordon, No. 430.

WHEREAS, Zoning Bylaw 23-08 shall replace Interim Development Control Bylaw 21-06, and regulates development within the RM of Invergordon, No. 430 to provide for the amenity of the area as well as for the health, safety and welfare of the inhabitants of the municipality.

WHEREAS, pursuant to *The Planning & Development Act* a public hearing must be held following the first reading of the bylaws, before Council may proceed with a second and third reading to adopt.

WHEREAS, a public hearing has been scheduled for 9:00am on January 10, 2024 in the Council Chambers, prior to the Regular Meeting resuming.

WHEREAS, pursuant to *The Planning & Development Act* public notice of the public hearing must be issued in a local newspaper. Accordingly, public notice shall be issued in *The Melfort Journal* and *PA Herald* on December 8, 2023 and December 15, 2023 as well as *The Rural Roots* on December 7, 2023 and December 14, 2023.

WHEREAS, public notice will also be mailed to each landowner and posted to the municipal website along with a copy of the proposed bylaws.
