### Fire Billing

WHEREAS, according to Fire Chief Daniel Morton, trees hitting a power line on the southern border of NE 6-44-24-W2 started the fire on May 17<sup>th</sup> 2020. The fire subsequently moved north onto SE 7-44-24-W2 where it destroyed numerous farm buildings and threatened a rural residence which was saved as a result of the Yellow Creek and R.M. of Hoodoo Fire Departments.

WHEREAS, Sask. Power was contacted during the event and responded to the scene. Trees were cut down the following day around affected power lines.

WHEREAS, the R.M. of Hoodoo has submitted their invoice to the municipality for responding to this call.

WHEREAS, due to the large scale of the fire as a result of heavy winds, additional fire fighting assistance was required in the form of 2 water trucks, 4 tractors and 100 liters of additional fuel, all provided by neighboring landowners.
